- 5) that they should follow the norms as prescribed in a circular issued by the University vide No. UNCCO/75 of 1986 dated 1st March, 1986 (copy enclosed)
- 6) that college shall not admit any student who is a public enemy of the state
- 7) the college shall appoint the Principal as per the conditions laid down for the B.A., B.Com. and B.Sc. in the circular No. 40 of 1987 (copy enclosed) and provide a letter with the names of the staff.

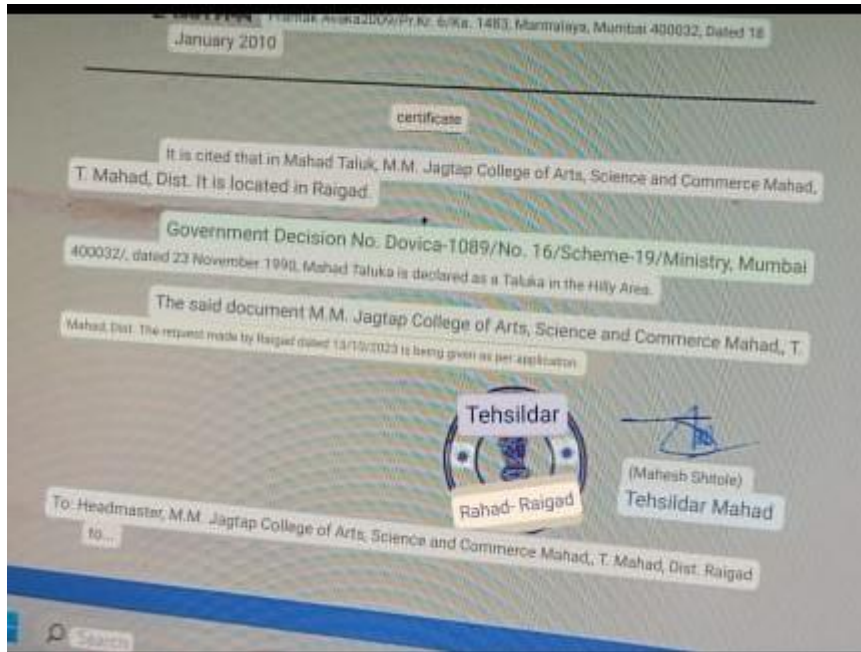
